

**50/50 RAFFLE: OFFICIAL RULES**  
**Money in Motion 50/50 Raffle (“Raffle”)**

**OFFICIAL RULES:** By participating, entrants agree to be bound by these Official Rules and by the decisions of **Muscular Dystrophy**, which shall be binding and final as to all matters related to the Raffle. The Raffle is subject to all applicable federal, provincial and local laws.

**NET PROCEEDS:** All net proceeds of the Raffle will benefit **Muscular Dystrophy Canada**, (hereafter known as “Sponsor”) and the programs and charitable donations that Sponsor supports. For purposes of Muscular Dystrophy, the raffle will be benefitting the equipment purchase program in Saskatchewan.

**PRIZES:** Winner will receive 50% of Gross Raffle Proceeds. (“Prize”)

**ELIGIBILITY TO ENTER:** During the dates and times and other details specified below, **Raffle tickets MAY BE PURCHASED ONLY BY PERSONS 18 YEARS OR OLDER** in accordance with these Official Rules. Raffle tickets may NOT be purchased by anyone under the age of 18, regardless of location or method of purchase.

The following persons are NOT ELIGIBLE to participate in the Raffle or to win any Prize: Officers, directors, shareholders, members, agents and consultants of The Sponsor and Tap 50:50 Event Consultants (collectively, the “Ineligible Parties”).

**PURCHASING RAFFLE ENTRIES:** The following prices and corresponding “ticket numbers” are available for purchase: 3 tickets for \$10.00, 10 tickets for \$20.00, 30 tickets for \$40.00 and 75 tickets for \$75.00.

**NUMBER OF RAFFLE TICKETS:** A maximum of 61,500 tickets will be sold.

**THE DRAW:** Potential winners will be selected by an approved RNG. One draw will be made. The draw will be made April 21, 2017 at 3:00 p.m. at the Muscular Dystrophy Canada office located at 1122 Paton Lane, Saskatoon, SK, S7W 0C1. The winning ticket number will be posted online.

**POTENTIAL WINNERS** will be notified by the sponsor by phone and/or email if an address is available. Owners of eligible entries need not be present in person at the Drawing in order to win.

**DETERMINATION OF OFFICIAL WINNER(S):** Sponsor shall have the sole discretion to determine whether each Potential Winner is an official winner of a Prize (an “Official Winner”). Sponsor’s decision concerning the identity of all Official Winners shall be final and binding. To become an Official Winner: (1) a Potential Winner must be eligible to participate in the Raffle under these Official Rules and must not be in violation of these Official Rules as determined in Sponsor’s sole judgment.

**AWARD OF PRIZE(S) TO OFFICIAL WINNER(S):** The Prize will be awarded to the Potential Winner who has been designated by Sponsor as the Official Winner. Failure of claiming the winning ticket within 365 Calendar days will result in voiding winning ticket. If no tickets are claimed to be winners within the allocated time-frame the prize will be awarded to a charity of choice by the Sponsor as

per SLGA guidelines.

All prizes will be sent to the Winner via cheque within 30 calendar days of Winning. For security and safety reasons, no cash payments will be made to winners.

**GENERAL CONDITIONS:** The Released Parties (defined below under “RELEASE OF LIABILITY”) are not responsible for: (1) Entries which are stolen, lost, damaged, illegible, given away or no longer in the purchaser’s possession, (2) Entries that have been or may have been tampered with or re-sold in violation of these Official Rules; (3) Entries or payments that are delayed, misdirected, undelivered, not fully captured, or garbled as a result of any failure or problem whatsoever with the availability, functionality, operability or use of any network, server, ISP, website, computer, telephone, cable or satellite modem or connection, hand held mobile device or any other computer equipment or connection, whether or not caused by site users, tampering, hacking, or by viruses, worms, or malfunctions affecting a network, server ISP or any equipment or programming used in or associated with the Raffle; (4) any other errors of any kind, whether human, typographical, printing, mechanical, or electronic in nature, which relate to or are connected with the Raffle (collectively, as described in clauses (1) through (4), “Errors”), including without limitation Errors in Raffle-related materials or in the administration of the Raffle, such as Errors in processing Entries, identifying Potential Winners, determining Official Winners, or announcing or delivering Prizes; or If any portion of the Raffle is compromised, in Sponsor’s sole judgment, by a virus, worm, bug, non-authorized human intervention or other causes which, in Sponsor’s sole judgment, corrupt or impair the administration, security, fairness or proper play of the Raffle, or the proper submission or capture of Entries (collectively, a “Compromising Event”), then Sponsor reserves the right, in its sole discretion, to suspend, modify or terminate the Raffle, and to select winners from all eligible, non-suspect Entries received before the known occurrence or discovery of such Compromising Event. All Entry purchases shall be final, and no refunds or replacements will be issued by Sponsor. Sponsor has sole and final decision on admissibility of entries and the determination of prize winner.

**RELEASE OF LIABILITY:** Entrants, by participating in the Raffle, agree that The Sponsor and Tap 50:50, each of their respective parents, affiliates, subsidiaries, partners, and advertising and promotion agencies, and all of their respective officers, directors, employees, representatives, shareholders, members, consultants and agents (collectively, the “Released Parties”) will have no liability whatsoever for, and shall be held harmless by entrants against, any liability for injuries, losses, cost, expenses or damages of any kind, including damages for death, personal injury, property damage.
